EdgeLine Dental Laboratory (“the lab”) warrants that all dental devices (a “device”) are made according to your specification and approval and the lab **MAKES NO OTHER WARRANTIES INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.**

If a device is placed and then fails due to defects in materials or workmanship, the lab will, at its election, repair or replace the device without charge for the cost of materials and workmanship or refund the original price paid for the device.

The duration of the limited warranty is as follows:

- (1) Seven (7) year warranty for porcelain to metal, all ceramic, single-unit inlay, onlay, and crown composite resin final prosthetics; and
- (2) Six (6) month thermoformed appliances and splints, provisionals, composite resin Maryland and inlay/onlay bridges.

This Warranty is exclusively for you, the Doctor purchasing the device, is not transferable and does not extend to any patients. You agree to pay all other costs of adjustment, repair and replacement of a device.

Except where prohibited by law, the lab **WILL NOT BE LIABLE FOR ANY LOSS OR DAMAGES ARISING FROM THE USE OF A DEVICE, WHETHER DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL**, regardless of the theory asserted, including warranty, contract, negligence or strict liability and if such disclaimer is not permitted by law, the duration of any implied warranty is limited to 90 days from the date of delivery.
